

ANNOUNCEMENT

The Cyprus Securities and Exchange Commission (“the Commission”) announces that applications are now being accepted for the examinations leading to registration in the Public Register of Certified Persons employed by Cyprus Investment Firms, Credit Institutions, Management Companies and Investment Companies of Variable Capital (“the Companies”).

The examinations will be conducted online on a weekly basis. (every Tuesday). There will be two examination sessions, in groups of 12 candidates, every Tuesday, starting from the 30th of September 2014. They are scheduled at 11.00 and 13.00 on the day of the weekly exam. Both examinations are offered at each session at the same time, in both English and Greek. No examinations will be held on Public Holidays. The frequency of the examinations may be amended based on demand.

It is noted that, until the end of November 2014, examinations will be conducted only in the English language. **Examinations in Greek will be offered from December 2014 onwards**, as the exam Workbook in the Greek language is expected to be ready in September.

The syllabus for the Basic and the Advanced Examination has been posted on CySEC’s website under the section [“Certifications and Public Register – Examination syllabus”](#).

The Basic Examination will be of a duration of one hour and will consist of 50 multiple choice questions. The Advanced Examination will be of a duration of one and half hours and will consist of 70 multiple choice questions.

A. Registration procedure for the certification examinations

Due to the fact that no examinations have been conducted for a long period of time, exemptions have been granted under Article 52(2) of the Investment Services and Activities and Regulated Markets Law of 2007-2012 (“the Law”), to individuals already employed in Companies.

Under this exemption, concerned individuals must pass the examination within one year, during which they can take the examination up to two times. If not, they must cease to provide the services in respect of which they were granted an exemption.

Therefore, for the period from 01/08/2014 until 20/08/2014, the Commission will only accept applications from exempted individuals, whose names are listed in the Table attached as **Appendix A**. It is understood that applications from exempted individuals will also be accepted after 20/08/2014, when the applications will be accepted from all interested individuals

In order to take the examinations, interested individuals must:

1. Pay the amount of €200 to take the Basic Examination or €300 for the Advanced Examination, through the JCC webpage, as follows:
 - Exemption holders (wishing to obtain the Basic Certification): *“Participation in the examinations for Registration in the Public Register (Exemption holders – Basic)”*, upon entering the serial number appearing against their name in **Appendix A**;
 - Exemption holders (wishing to obtain the Advanced Certification): *“Participation in the examinations for Registration in the Public Register (Exemption holders – Advanced)”*, upon entering the serial number appearing against their name in **Appendix A**;
 - Other interested individuals: *“Participation in the examinations for Registration in the Public Register”*, upon entering the requested information.
2. Complete [the application form](#) and send it to: certifications@cysec.gov.cy

The form allows candidates to choose the examination and two possible dates on which they wish to take the examination. For the time being the Commission will accept applications for exams that will be carried out until Tuesday 31/03/2015.

Please note that it is not possible to register for both examination levels on the same form. The choices made regarding possible examination dates will be taken into consideration, however it is estimated that it will be impossible to satisfy all requests due to the large number of applications. If this is the case, you will be given the closest available examination date.

It will be possible to transfer the exam dates in accordance with the [Exam Regulations and Policies](#).

Upon completion of the registration and the payment of the relevant fee, candidates will be sent, in electronic form, the fixed examination date together with the exam Workbook to help in their preparation.

The preparation of the exam Workbooks has been based on the Exam Syllabi and they should be studied for the exams. The Workbooks include sample multiple choice exam questions. The Workbooks for the Basic and the Advanced Examinations consist of around 180 and 280 pages, respectively. The time required for the study of each Workbook is estimated at 90 hours.

B. Examination results and registration with the Public Register

Upon completion of the examination, candidates will be notified immediately whether they have passed and the detailed results of the examination will be sent by email at a later stage.

On receiving this email, successful candidates may register with the Public Register, upon sending a relevant registration application with their contact details to: certifications@cysec.gov.cy. Applications for registration with the Public Register will be available on the Commission's website.
